Declares Monthly Distribution

Toronto, August 4, 2010: Core Canadian Dividend Trust (the Fund) has declared its monthly distribution of C\$0.03878 per unit payable August 31, 2010 to unitholders of record as of August 16, 2010.

The Fund s investment objectives are: (i) to provide unitholders of the Fund with monthly cash distributions in an amount targeted to be 6.5% per annum on the net asset value (NAV) of the Fund; and (ii) to preserve and grow the NAV per unit. The Fund invests in a blue-chip portfolio consisting of high-quality, large capitalization, dividend paying Canadian companies across multiple industry sectors that have an excellent long-term track record of dividend growth and share price appreciation.

To generate additional returns above the dividend income earned on the Fund s investment portfolio, the Fund may, from time to time, write covered call options in respect of some or all of the securities in the portfolio. In addition, the Fund may write cash covered put options in respect of securities in which it is permitted to invest.

The Fund s investment portfolio is managed by its investment manager, Mulvihill Capital Management Inc. Fund units are listed on the Toronto Stock Exchange under the symbol CDD.UN.
